Hello community members and providers,

I am writing to share that The People Concern SPA 4's Problem-Solving Program is accepting referrals. Problem Solving is available for clients who are in need of the following financial assistance including but not limited to:

- Move-in fees- Security deposit and first month's rent/prorated rent
- Rental Arrears for two months only. Client should not have a balance after the arrears are paid.
- Host Household Assistance- Financial assistance for family/friends to divert a family or individual into a temporary housing situation. The host household must be able to commit to a minimum stay.
- Utility Assistance- To prevent loss of housing or to re-house. Eligible utilities include gas, electricity, water, and trash.
- Reunification Services
- Motel/Hotel- Temporary motel/hotel lodging in conjunction with reunification services, for participants waiting on departure date from transportation provider.
- Furniture/Household Supply Assistance- Furniture or household supplies needed to establish temporary or permanent housing.

Eligibility:

- Residing in SPA 4
- Income does not exceed 50% AMI (\$41k/year)
- Experiencing homelessness or at immediate risk of experiencing homelessness

Referral Process:

- Gather the following documents and submit to CESproblemsolving@thepeopleconcern.org
 - Referral Form
 - ID
 - Income Verification within the last 90 days
 - Last three pay stubs if employed
 - Additional documents may be required depending on the client's situation
